From Bird Rock Community Council (BRCC) President Joe Terry

In July, there were two amazing examples of the Bird Rock community coming together with great results. First, there was the extremely successful Beaumont Ave. 4th of July parade. Once again, the Murfey family and company organized this fantastic event for the greater Bird Rock community. There was outstanding community support in terms of the creative floats prepared for the parade, including the BRCC VW surf bus, the hundreds/thousands of people in the parade, cheering them on and enjoying the postparade band, other activities and food. That level of community involvement is one of the things that makes Bird Rock such a special community.

Second, about 40 Bird Rock residents and business owners attended the La Jolla Planned District Ordinance (PDO) Committee meeting on July 10. This was a critical meeting because the Committee was beginning its process for making recommendations to "improve" the La Jolla Planned District Ordinance (San Diego Municipal Code, Section 159). During the meeting, the Committee reviewed: 1) The Purpose and Intent of the LJPDO and 2) Ground floor Retail Requirements in LJPDO Zones 1 through 4. Bird Rock is in Zone 4. The Committee seemed responsive to the message that: 1) the Bird Rock commercial district is thriving; 2) it is part of what makes Bird Rock such a great place to live, work and visit; and 3) it would be put at risk by eliminating the current PDO requirements for ground floor retail space. Those from Bird Rock who spoke found different ways to make those points and to suggest methods to improve the process of updating the LJPDO. Those suggestions included: 1) conducting a community wide poll to determine the Bird Rock Community's opinions on the current LJPDO requirements for ground floor retail space and possible changes to the LJPDO; 2) having an independent





Welcome to a new school year! Ways to Make This the Best School Year Ever...

1. Traffic safety: We have a great safety record at BRE because most everyone makes a sincere effort to work together to keep drivers, bikers, skateboarders, and pedestrians safe. Be part of the solution! Commit to following the directions of the teachers and Safety Patrol, keeping in mind that the only reason they are there is to prevent someone from getting hurt.

2. Be positive: Communicate to your child through your own upbeat words and body language that this is going to be a great school year! They get to reconnect with BRE friends and have interesting and mind growing learning experiences. A different kind of fun is on its way!

3. Demonstrate your trust of the teacher and classroom: Give your child a quick hug and kiss...and then leave. There may be tears initially, but by leaving quickly you communicate to your child that you believe that he or she is safe in this place.

6. Label EVERYTHING: Busy days means things are going to get lost or left behind. Labeling personal belongings goes a long way towards helping your child reunite with their stuff.

professional assessment of the impact of any proposed changes to the LJPDO; and 3) strengthening committee member conflict of interest rules. The Committee recognized that the appropriate changes to the LJPDO regulations would differ by area within La Jolla. It decided to work on changes to the LJPDO during its monthly meetings and not to have a sub-committee propose changes.

The Committee will probably take several months to draft and agree on proposed changes to the LJPDO and that is only the first step in updating the LJPDO. Continued and broad efforts by the greater Bird Rock area community will be required to ensure that any changes to the LJPDO benefit that community rather than just narrow interest groups. The process for implementing changes to the LJPDO includes the PDO Committee making its recommendations to the La Jolla Community Planning Association (LJCPA), the LJCPA making its recommendations to the City, and both the City Council and the California Coastal Commission approving the proposed changes. The community will need to be effectively involved in each step of that process. Your participation in this process is essential, where that participation can include sharing your ideas and expertise and attending the meetings at which recommendations or decisions will be made about changes to the LJPDO. Services provided include dog licensing, lost and found, adoptions, microchipping, spay/neuter, vaccination clinics, educational programs, and cruelty reports.

Residents can report animal-related concerns by email at investigations@sdhumane.org or by phone at 619-299-7012 ext. 1 (open 24 hours a day/7 days a week) or by submitting a form to SDHS Humane Law Enforcement (HLE) [https://www.sdhumane.org/services/humane-law-enforcement/]. If you are reporting an animal-related emergency, cruelty, or imminent threat or danger to animals or humans, please call HLE dispatch at 619-299-7012 ext. 1. The email address investigations@sdhumane.org is checked frequently, but not in immediate real time.

Animal Licenses - [https://www.sdhumane.org/services/licensing/]- All dogs, four months of age and older, must have a valid license and wear it at all times. Owners must demonstrate proof that dogs have been properly vaccinated for rabies in order to receive a license. More information can be found at the SDHS Vaccinations page

Each DocuPet tag serves as a pet's official license and comes equipped with the HomeSafe™ [https:// sandiego.docupet.com/en_US/homesafe] 24/7 lost pet service, which relies on a dedicated full time dispatch staff and linked pet profiles to help get lost pets home quickly.

Visit sandiego.docupet.com to license your pet now.

Lost or Found Pets - Visit SDHS during operating hours from 10 a.m. to 6 p.m., Tuesday through Sunday (closed on Mondays). If you have a picture of your pet, please bring it with you.

Dead Animal Removal - To request the removal of a dead animal from the public right-of-way within the City of San Diego, use the City's Get It Done app or call Environmental Services at 858-694-7000 from 6:30 a.m. to 5 p.m. This is also the number to use for after-hours messages and emergencies.

City of San Diego Leash Laws - Dogs must be kept on a leash not to exceed eight (8) feet at all times except when at a designated off-leash area or confined to a residence or backyard. Leash law requirements are also enforced at City parks including canyons and trails.

BIRD ROCK COMMUNITY MEETING, June 6, 2023

Bird Rock Community Council (BRCC) Board President Joe Terry called the meeting to order at 6:05 pm in the Bird Rock Elementary School auditorium, welcomed attendees, introduced BRCC Board members, and made remarks.

Updates from Representatives of Elected Officials

Steven Hadley (SRHadley@sandiego.gov), Director of Community Outreach for Joe LaCava, San Diego City Council District 1. Modifications to Spaces As Places program and resulting amendments to the San Diego Municipal Code and Local Coastal Program, as suggested by the California Coastal Commission (CCC), were approved by the San Diego City Council. The revised ordinance is expected to return to the CCC for final approval in September or October and will be applicable to the Coastal Zone. The revisions include a requirement to obtain a Coastal Development Permit and the need to replace or provide nearby parking within 1200 feet of the restaurant and equivalent to the number of parking spaces that are converted to outdoor dining or other uses.

Infrastructure Problems: Defective/Outdated Pedestrian Signals The BRCC awaits the status of an application submitted to State Assemblymember Tasha Boerner for a proposed \$50,000 supplemental funding to replace pedestrian crossing signals on La Jolla Blvd in the Bird Rock commercial district. An inquiry was sent to Traffic Engineering about automated signals. New, highly visible signals would enhance pedestrian safety, promote walkability and business district access, and support the City's Climate Action Plan. Volunteers are needed to check the pedestrian crossing signals and report problems to Get Done or info@birdrockcc.org.

Lighting Project Along La Jolla Blvd. between Camino de la Costa & Midway Street The BRCC is proceeding with a proposed lighting project along La Jolla Blvd. to improve nighttime safety and the commercial identity of Bird Rock. The project will include improvements to the streetlights and building lighting and the addition of decorative lighting. The BRCC is reviewing the types of lighting installed in the public right of way in La Jolla and elsewhere in San Diego and preparing a list of questions for the Development Services Department and Parks & Recreation

Department concerning permissible lighting. Steve Hadley agreed to help obtain responses from DSD and Park and Recreation Dept. After responses are received, cost estimates for permissible alternatives and community input will be obtained, followed by fund raising.

I Love a Clean San Diego, Adopt-A-Beach program for Sun Gold Point/PB Point BRCC is submitting an application to the I Love a Clean San Diego, Adopt-A-Beach program requesting adoption of the Sun Gold Point/PB Point beach. The beach is assessable from the San Diego Park and Recreation Dept. stairs located at 403 Sea Ridge Drive, at the intersection of Linda Way and Sea Ridge Dr. Access instructions including a warning to avoid walking on or near unstable bluffs which have the potential for sudden collapse.

To participate, BRCC will organize 3 clean-up events each year that must be pre-scheduled with "I Love a Clean San Diego." The events include trash collection and clean-up, documentation and itemization of the collected trash, and at least annual reporting of the itemized trash (including quantity or weight). The BRCC may be eligible for recognition in the temporary sign program if the clean-up is done properly with detailed reporting of collected litter. A BRCC board member will organize and facilitate the clean-up events once Adopt-A-Beach program approval is received, and the Bird Rock neighborhood will be notified and asked to help.

Bird Rock Signage/Monument Project

Senior Traffic Engineer Gary Pence indicated that a proposed Bird Rock sign or rock could be no more than 30" in height when measured from grade (if placed inside a roundabout) and no higher than 36" above the roadway due to line-of-sight rules. Per Mr. Pence, the Development Service Department (DSD) would review any proposed addition of one or more pelicans on top of a rock if the height was in excess of the 30" limit to determine whether visibility is blocked. Mr. Pence and others expressed concerns about vandalism, theft of pelicans, and pranks and noted that a pelican logo etched into the rock or other options would be a better option. The height requirements were shared with Trace Wilson for preparation of 3 signage/monument options for Bird Rock Community review.

Don Schmidt noted that there were ongoing ADA compliance problems along sidewalks within the Bird Rock commercial areas due to encroachment of businesses into the public rights of way. He noted an example of tables and chairs blocking access and reducing sidewalk width at the northwest corner of Forward St. and La Jolla Blvd and near the pedestrian crossing area. This is a code compliance issue which can be reported via the City's Get-It-Done app.

New plantings were noted at La Jolla Hermosa Park. Bird Rock Merchants Group is working on a grant for lighting and signage, want to create a Bird Rock app and merchant map/catalog, and are concerned about conversion of business space to housing.

Bird Rock Maintenance Assessment District Update

There was a major traffic accident on Sat. May 20 at around 3 am at the Camino de la Costa roundabout and the adjacent southwest MAD area. A DUI vehicle crashed through the west side of the roundabout hitting and damaging street signs, curbs, plants, and the irrigation system. The southbound vehicle continued into and through the entire corner of La Jolla Blvd, southwest of Camino de la Costa doing major damage until it stopped adjacent to 5762 La Jolla Blvd. The new backflow cage and irrigation controller were destroyed. The City backflow for the irrigation system was sheared off at ground level resulting in a broken water pipe and gushing water. The cement backflow base pad was cracked. Substantial plant and irrigation system damage occurred from the crash, and there was water damage to the adjacent area.

The police responded, and a City crew shut off the water. The City street sweeper cleaned up most of the roadway debris shortly after 6:30 am Saturday morning. The MAD landscape crew cleaned up the remainder of the debris in the street as well as in the MAD areas and sidewalk. The driver was reported as having an alcohol level above the legal limit and was cited by SDPD. A full SDPD report should be available soon, and Matt is obtaining damage and repair estimates and will follow up with the City Claims Department regarding attempts to collect for damages. Hopefully, the MAD can recover the costs to repair, restore, and replant the area. The City will install a new water pipe and backflow valve. In the meantime, irrigation is shut off.

Planned irrigation system retrofit and replanting in the La Jolla Mesa MAD areas are scheduled to take place in late June and July. Due to the age of the irrigation systems, controllers throughout the MAD are scheduled for replacement, retrofit, or upgrades. Scheduled irrigation system inspections continue as part of the preventive maintenance plan.

Maintenance, pest management, and trimming of the Bird Rock street trees continue on a regular basis to keep trees healthy and away from buildings, to maintain lower branches at a safe height above pedestrians and for visibility and line of sight reasons, and to comply with the San Diego Municipal Code, Fire Code, and vector control concerns. Annual tree shaping and canopy trimming is coordinated with a master arborist and scheduled for the fall.

Since the MAD is responsible for maintaining safe and clear Public Right of Ways, clear pedestrian and vehicular lines-of-sight, and pedestrian access, illegal signage is proactively dealt with. ADA compliance issues, such as blocked sidewalks, continue to be noted and reported.

Follow up continues for various City Street Division service requests. The deteriorated, raised, and improperly locked utility cover near 365 Bird Rock Ave. posed a pedestrian safety hazard. City repair of the April 21 emergency waterline break and repair of the roadway just south of the Midway roundabout are being monitored since a small water leak and additional curb and roadway damage were noted. The subsiding temporary asphalt roadway patches will be reported.

Finally, the next quarterly MAD meeting is scheduled for Sept 5 following the regular Bird Rock Community meeting. The Annual MAD meeting is November 7. Anyone with question or comments about the Maintenance Assessment District or with information about any accidents that involved the MAD public right of way areas is asked to contact the MAD Consulting Manager Matt Mangano at admin@ManganoConsulting.com.

Coyote Sightings

Concerns and comments about coyotes and sightings were reported and briefly discussed. More information will be forthcoming. It was noted that leaving pet food outside, particularly overnight, attracts coyotes and nocturnal animals such as opossums, raccoons, skunks, rats, and feral cats.

Bird Rock Community Council (BRCC) Board President Joe Terry called the meeting to order at 6:07 pm in the La Jolla Masonic Lodge, welcomed attendees, introduced BRCC Board members, and made remarks.

Updates from Representatives of Elected Officials

Steven Hadley (SRHadley@sandiego.gov) is retiring as Director of Community Outreach for Joe LaCava, San Diego City Council District 1, and Emily Lynch, will be the new Community Outreach Director for Councilmember Joe LaCava. Both were unable to attend.

Process to Update the La Jolla Planned District Ordinance, San Diego Municipal Code §159

On July 10, the La Jolla Planned District Ordinance Committee (a subcommittee of the La Jolla Community Planning Association) began reviewing the La Jolla Planned District Ordinance (San Diego Municipal Code §159) with the goal of providing updates to the City. The LJPDO Committee discussed 1) the purpose and intent of the LJPDO and 2) ground floor retail requirements in LJPD Zones 1 through 4. The 3-block Bird Rock commercial district is zoned LJPD4.

A number of Bird Rock residents and business owners attended the July LJPDO meeting. During public comment, it was noted that the Bird Rock commercial district is thriving and an important part of the Bird Rock neighborhood and that elimination of required ground floor retail space would severely impact the district. Zoning restrictions differ by area within La Jolla. Updates to the La Jolla Planned District Ordinance will be addressed at future meetings.

Infrastructure Problems: Replacement of Defective/Outdated Pedestrian Signals

Anthon George, Customer Service Program Manager, San Diego Transportation Department, told Steve Hadley the City would only upgrade or install signals like those installed elsewhere in San Diego. The BRCC will pursue various funding sources for safer and more visible signals to replace the malfunctioning, less visible pedestrian crossing signals currently installed in Bird Rock.

Volunteers are needed to periodically check the pedestrian crossing signals and report problems to Get Done or info@birdrockcc.org.

44th Annual Beaumont Avenue 4th of July Parade

The Murfey families and Murfey Company organized a fantastic "Surfing USA-themed" parade which celebrated community, country, and patriotism. The community-supported event included great home-made floats, a thousand attendees, a post-parade band, other activities, and food. This very special event contributes to the unique character of the Bird Rock neighborhood.

I Love a Clean San Diego, Adopt-A-Beach program for Sun Gold Point/PB Point

The BRCC is looking for a volunteer to oversee the Adopt-A-Beach program including 3 cleanups per year, organizing volunteers, and documentation of collected trash.

Don Bravo Food Truck

Resident Carol O'Brien expressed concerns about the food truck in the Don Bravo parking lot, potential sidewalk/public right of way encroachment, permits and use as an additional kitchen area, and bright lights shining into neighboring properties at night. Further discussion ensued.

Bike Path Maintenance – Volunteer Participation, Accomplishments, and Future Cleanups

Volunteer Debbie Adams continues to help organize the approved clean-up efforts of the Fay Avenue Extension Bike Path which have evolved from an annual event to more frequent, smaller seasonal cleanups as the need for maintenance has increased over the years. In the beginning, efforts were directed toward removal of trash, dumped construction debris and items, and dry flammable brush. Over time, maintenance has shifted to removal of dry brush and abandoned camp areas, brush abatement, removal of potential fire hazards, bike path safety, and more.

Efforts are focused on the bike path area including 17 acres of designated open space, 2 adjacent pocket parks, Alta Way, the south end big field, and dirt paths. The bike path area is under the jurisdiction of various City departments including Traffic and Transportation, Storm Water, and Real Estate Assets. City Right-of-Entry Permits are obtained with the help and financial support of the nonprofit La Jolla Kiwanis and the assistance of Kiwanis member Glen Rasmussen. Donations designated for bike path maintenance and clean-up can be made to the La Jolla Kiwanis. In anticipation of a very dry season, volunteers continue to remove dry brush along the bike path.

July cleanup is focused on removal of dry brush starting at the south end and moving northward. Ms. Adams invites everyone to join the clean-up effort. Contact Ms. Adams at ljbird45@gmail.com .

La Jolla Community Planning Association

At the July 6 LJCPA meeting, three projects in or near the Bird Rock area were pulled from the consent agenda for full review at the August 3 LJCPA meeting. Those projects are located at 625 Wrelton Drive (project # 696528), 5646 Chelsea Street, and 5960 Camino De La Costa. Adelante Townhomes Development Update

The City Development Services Dept continues to review the project and has requested more information prior to making a recommendation to the Planning Commission. DSD requests include: 1) written findings from the applicant to demonstrate how each building standard for which a waiver is requested would physically preclude the construction of this development and 2) assurance from the San Diego Housing commission that the development would include a for-sale dwelling unit for a very low income household, a requirement to qualify for the requested density bonus, incentives, and waivers in order to comply with the La Jolla Planned District and other parts of the SDMC.

Bird Rock Signage/Monument Project

Three proposed signage/monument options are to be prepared for Bird Rock Community review. Potential funding sources are being reviewed.

La Jolla Blvd. Lighting

The BRCC is proposing to enhance lighting in the Bird Rock commercial district along La Jolla Blvd. for improved nighttime safety and to enhance the identity of the Bird Rock commercial district. A commercial district lighting project could include lighting of street trees on the sidewalks and enhanced median lighting. Allowable types of lighting need to be determined as well as feasibility and costs. Various alternatives are proposed to be presented to the Bird Rock Community to identify a preference. Funding and City approvals would also be necessary.

Bird Rock Merchants Group member Craig Bender reported that merchants are working on various ideas including a business district map and catalog and a merchant discount app. The group wants to see retail usage on the ground floor of the Adelante project.

Bird Rock Maintenance Assessment District Update

The Bird Rock MAD FY24 budget was approved as part of the City budget at the City Council meeting on June 12, 2023.

MAD Consulting Manager Matt Mangano has negotiated a contract extension renewal with Urban Landcare for fiscal year 2024, effective 7/1/23, for regular landscape services. Contract provisions for extra work remain in effect. Labor expenses will continue to comply with the City of San Diego Living Wage Ordinance and other City labor provisions.

Urban Landcare is doing a fantastic job as is MAD consulting manager Matt Mangano.

Due to liability issues regarding MAD maintained trees, tree wells, and potential "trip and fall" lawsuits, discussions continue regarding a proposed addition of an amendment to the existing Bird Rock MAD contract regarding sidewalk conditions; sidewalk maintenance, repair, replacement, and liability; and clarification of responsibilities and the process in the event of a claim or lawsuit against the City for damage or injury arising from certain "dangerous conditions." Similar amendments are being drafted for other MADs overseen by the San Diego Economic Development Dept. and by the San Diego Park and Recreation Dept. Councilmember Joe LaCava and his office are helping with this process. We understand that the proposed amendment is being reviewed by the City Attorney.

The City backflow at the southwest corner of La Jolla Blvd and Camino de la Costa, which was the site of a major DUI traffic accident on May 20, has been replaced. A new backflow cover is being ordered, and caution tape remains in place until all repairs are completed. Matt is obtaining damage and repair estimates and following up with the City Claims Dept. regarding attempts to recover damages.

Planned multi-step irrigation system retrofit and replanting in the La Jolla Mesa MAD areas are underway and involve proper soil preparation and amendments as well as irrigation system retrofit before any plantings can occur. Scheduled work is contingent upon funding, personnel availability for this project, and weather conditions. MAD irrigation controllers are scheduled for replacement, retrofit, or upgrades this fiscal year.

Due to vigorous tree growth, street tree maintenance has increased. Some need to be pruned away from buildings. Tree skirts will be raised to safe heights above pedestrians and for visibility and line of site reasons. Weekly pest control, fertilization, and branch trimming are ongoing. Annual tree shaping and canopy trimming is scheduled for fall.

Service Requests to City Street Division are being monitored regarding ADA compliance, safety issues, water leaks, and other problems.

The next quarterly MAD meeting is scheduled for Sept 5 following the regular Bird Rock Community meeting. The Annual MAD meeting is November 7, 2023, following the regular community meeting and tentatively scheduled at the Bird Rock Elementary School auditorium.

Next Community Meeting

There is no August community meeting. The next meeting will be in person on Sept. 5 at Bird Rock Elementary with limited Zoom access (details at https://www.birdrockcc.org). The quarterly Bird Rock MAD meeting will immediately follow the September Community Meeting. Agendas and additional information for meetings will be posted at http://www.birdrockcc.org.
